Dear Southwest ISD Family,

On Tuesday, August 10, the City of San Antonio and Bexar County was granted a temporary restraining order to prevent enforcement of Governor Abbott's executive order banning masks mandates in Texas schools. In response, the San Antonio and Bexar County Health Authority has issued a health directive stating the following:

“Schools shall follow the Centers for Disease Control and Prevention (CDC) recommendations for universal indoor masking and require all students (age 2 and older), staff, teachers, and visitors to K-12 schools, regardless of vaccination status, to wear a face mask indoors.”

SWISD will continue to monitor the status of the temporary restraining order and will update staff and the community as more information becomes available.

Estimada familia de Southwest ISD:

El martes 10 de agosto, la ciudad de San Antonio y el condado de Bexar recibieron una orden de restricción temporal para evitar la aplicación de la orden ejecutiva del gobernador Abbott que prohíbe los mandatos de máscaras en las escuelas de Texas. En respuesta, la Autoridad de Salud de los condados de San Antonio y Bexar ha emitido una directiva de salud que establece lo siguiente:

“Las escuelas seguirán las recomendaciones de los Centros para el Control y la Prevención de Enfermedades (CDC) para el enmascaramiento interior universal y requerirán que todos los estudiantes (de 2 años en adelante), el personal, los maestros y los visitantes de las escuelas K-12, independientemente del estado de vacunación, usen un mascarilla en interiores ”.

SWISD continuará monitoreando el estado de la orden de restricción temporal y actualizará al personal y a la comunidad a medida que haya más información disponible.
